- All the conditions of affiliation prescribed by the affiliating University or Board will have to met by the institution.
- The college authorities will recruit the staff as per Government /University / PCI guideline and pay the salary to the staff in the pay scale prescribed by the Govt. from time to time.
- Tuition fee and other charges will be as per the norms prescribed by Government/ affiliating University /Board.



- The Government can impose any other condition(s) at any time, which shall be binding on the institute.
- Any contravention of the above stated conditions shall result in withdrawal of the "No Objection Certificate" and action deemed fit against the defaulting society / institution.
